

Social Security: Kansas Quick Facts



Kansas's aged population is expanding.

In 2003, Kansas's population was about 2,724,000 with 13% being age 65 and older (354,000 residents).¹ In 2015, the 65+ population will make up 15% of the state's population, and in 2025, it will be 19%.^{2,3}

Kansas ranks 28th in income level among the U.S. States.

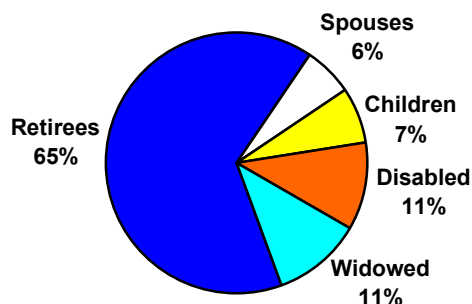
The average personal income in Kansas was \$29,438 in 2003. Kansas's per capita income (28th) ranks higher than Texas (30th), and Oklahoma (40th).⁴

One in six Kansas residents receives Social Security.

The Social Security program not only provides monthly benefits to retired workers, but also to families when the worker retires, dies, or becomes disabled. In 2003, over 47 million Americans received Social Security benefits; of these, 443,830 live in Kansas.⁵

In 2003, one in six Kansas residents received Social Security. While 65% of beneficiaries are retirees, 35% are not: 48,000 are disabled workers; 47,200 are widows and widowers; 32,800 are children; and 26,230 are wives and husbands.⁶

Social Security pumps over 4 billion dollars into Kansas's economy.

In 2003, Kansas residents received 4.6 billion dollars from Social Security.⁶ The average yearly Social Security benefit for a Kansas retiree in 2003 was \$11,327—or about \$944 a month.⁵

Nearly all Kansas residents age 65 or older receive Social Security.

Nationally, almost 16% of all people receive Social Security benefits; in Kansas, 16% of residents do. However, older people are more likely to receive the benefit, with 91% of those over age 65 receiving it nationwide, and 94% of older Kansans receiving it.¹

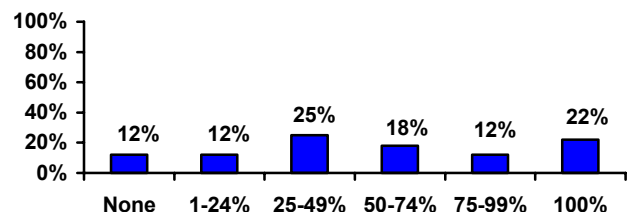
Social Security lifts nearly half of retirees from poverty.

Nearly half (47%) of the nation's older population would be living in poverty if they were not receiving Social Security. In Kansas, 46% of the state's 65+ population (150,000 people) would have incomes below the poverty line if they did not have Social Security.⁷

Social Security is the only source of income for one fifth of Kansans age 65+.

Social Security makes up 50 percent or more of the income for over half of Kansans age 65 and older. One fifth of older Kansans rely on Social Security as their only source of income.⁸
