## Executive Summary

In late October 2006, AARP commissioned a national telephone survey (titled AARP Election Watch: Pulse of a Generation) of a representative sample of Boomer+ or people ages 42 and older, who constitute the segment of the population who are most likely to vote. In fact, 90 percent of respondents in the current survey report they are already registered to vote and 88 percent are likely voters. A total of 1,006 interviews were conducted.

### Issue of the Week: Medicare

Approximately half of all boomer+ respondents (48%) think that Medicare's new prescription drug plan will be good for older Americans who have difficulty paying for their prescriptions. Nearly 4 in 10 respondents (37%) ages 42 and older think the plan will be *good* for older Americans and 11 percent think this plan will be *very good*.

Half of all respondents (50%) report they have read, seen, or heard a *great deal* (27%) or *a fair amount* (23%) about Medicare's prescription drug plan. One fifth of all respondents (20%) report they have read, seen, or heard *some* (21%) or *very little* (20%) about the plan.

### Voting Participation

Self reported voter registration is very high (90%). Respondents say that they are also *very likely* to vote this November (88%).

Survey respondents report voting with regularity – 59 percent say they *always* vote and 27 percent say they *nearly always* vote. Sixty-seven percent of those over 60 say that they *always* vote compared to 44 percent of younger boomers (ages 42 to 50) and 55 percent older boomers (ages 51 to 60).

Interest in the upcoming election is high. Six in 10 (63%) say they are *very interested* in this year's election.

As of October 20<sup>th</sup>, with just two full weeks before the election, 58 percent say they have given *quite a lot* of thought to the upcoming election, and less than half (46%) say they have not yet decided which candidate they will vote for in their House of Representatives race. Less than 4 in 10 (37%) have not yet decided which candidate they will vote for in their U.S. Senate race.

Americans are narrowly divided between basing their vote for congressional candidates on “bringing home the bacon” to their congressional district (41%) and agreement with the candidate's position on major national issues (45%).

On the other hand, more say a candidate's position on one or two key issues (45%) matters most when they vote rather than the personal qualities of the candidates (35%).

## **AARP Election Watch: Pulse of a Generation**

### **October 30, 2006**

As the upcoming mid-term elections draw near, AARP wanted to take the pulse of the public's opinion on issues that our members have indicated they want to hear about in the national and state public discourse. AARP also wanted to determine how much attention people are paying to the elections and what they consider when making their voting decisions.

This *AARP Election Watch: Pulse of a Generation* survey is the seventh in a series of 9 surveys scheduled for release each week leading up to the mid-term elections. The first seven reports dealt with the issues of ID theft, affordability of prescription drugs, Social Security (fielded and reported twice: week of 9/25 & 10/23), consumer privacy, healthcare coverage and long-term care. This report is about Medicare. Additionally, this report includes a weekly reporting of changes in boomer+ voters' level of interest and opinions leading up to Election Day.

In late October 2006, AARP commissioned a national telephone survey of a representative sample of people ages 42 and older, who constitute the segment of the population who are most likely to vote. In fact, 90 percent of respondents in the current survey report they are already registered to vote and 88 percent are likely voters. Moreover, 59 percent say they *always* vote and another 27 percent say they *nearly always* vote. A total of 1,006 interviews were conducted.

The survey methodology is described at the end of this report, and a tabulated questionnaire is appended.

## Key Findings

### Awareness and Opinions of The Medicare Prescription Drug Plan

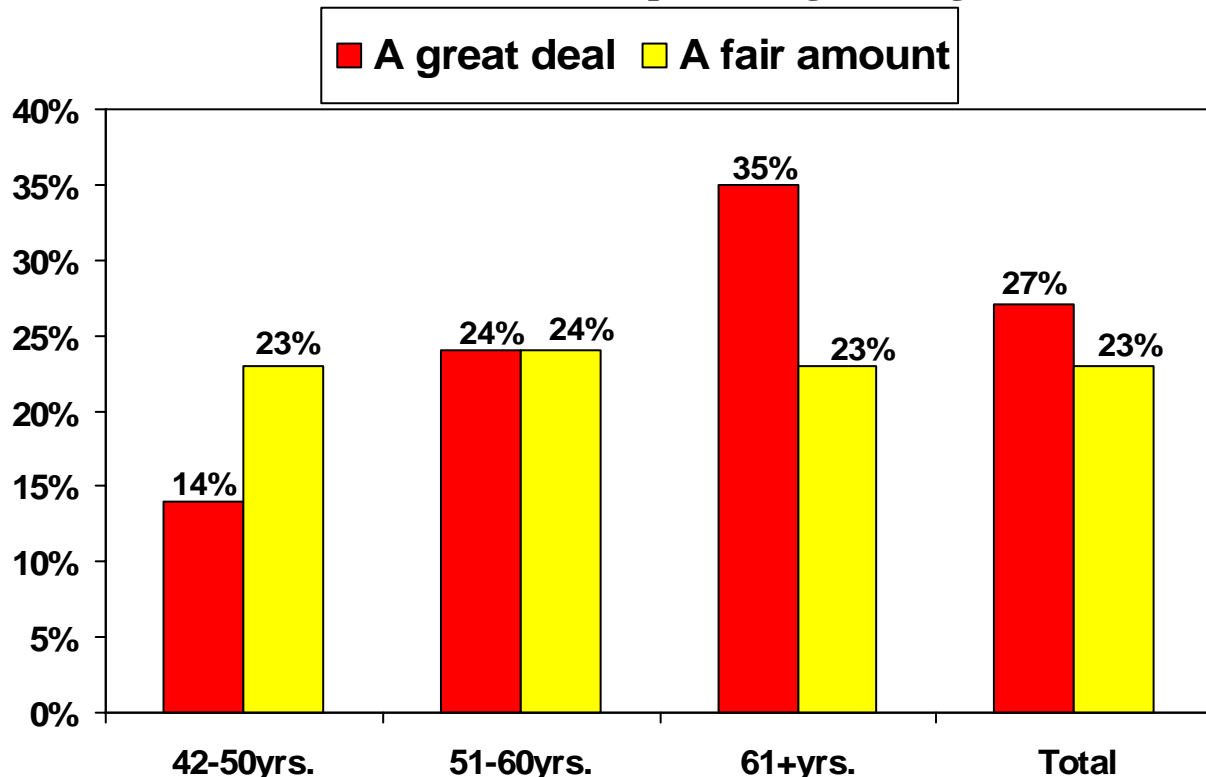
On January 1, 2006 Medicare started to offer insurance coverage to help people pay for prescription drugs. The new program is known as Medicare Part D. While the current poll does not measure the incidence of participation in the Medicare prescription drug plan it does suggest there is a considerable level of awareness about the plan. A fair percentage of boomer+ respondents report they have some knowledge of an individual who is participating in the plan. A total of 4 in 10 respondents ages 42 and older have either joined the prescription drug plan (15%) or, have a family member or know someone who has joined the plan (27%).

Furthermore, half of all boomer+ respondents (50%) report they have read, seen, or heard a *great deal* (27%) or a *fair amount* (23%) about Medicare's prescription drug plan (see Figure 1). One fifth of all respondents (20%) report they have read, seen, or heard *some* (21%) or *very little* (20%) about the plan. Only six percent report they have read, seen, or heard *nothing at all* about the Medicare prescription drug plan.

A greater percentage of respondents ages 61+ are more likely (35%) than younger boomers ages 42 to 50 (14%) and older boomers ages 51 to 60 (24%) to report they have read, seen, or heard a *great deal* about the Medicare prescription drug plan.

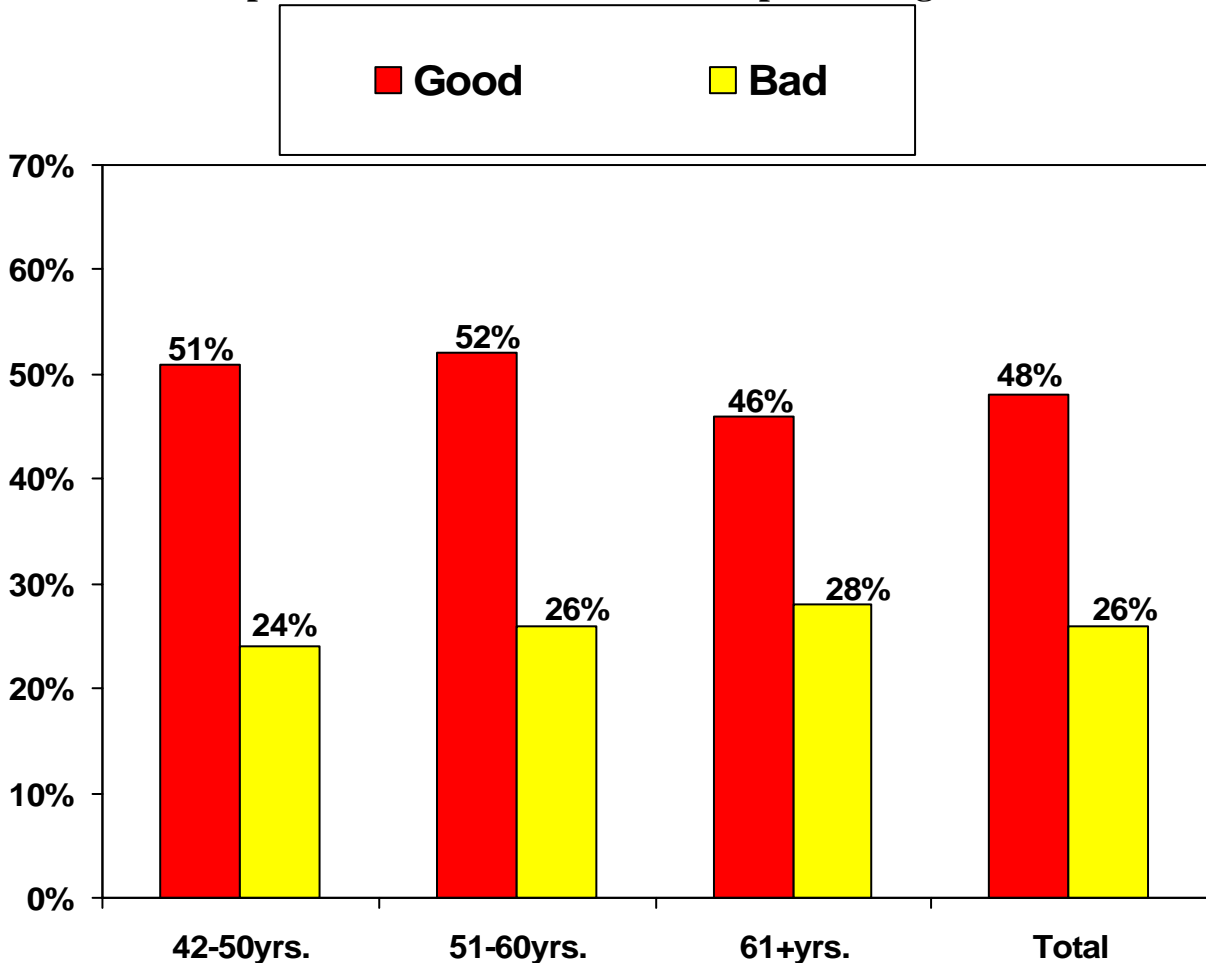
#### How Much Have You Read, Seen, or Heard About Medicare's Prescription Drug Coverage?



Approximately half of all boomer+ respondents (48%) think that Medicare’s new prescription drug plan will be good for older Americans who have difficulty paying for their prescriptions (see Figure 2). Nearly 4 in 10 respondents (37%) ages 42 and older think the plan will be *good* for older Americans and 11 percent think this plan will be *very good*. One-quarter of all boomer+ respondents (26%) think Medicare’s prescription drug plan will be a bad thing for older Americans who have difficulty paying for their prescriptions (see Figure 2). Less than 1 in 5 respondents (17%) think the plan will be *bad* and 9 percent think the plan will be *very bad* for older Americans who have difficulty paying for their prescriptions. A full one-quarter of all respondents (25%) say they “*don’t know*” what to think about the plan.

There are very little differences of opinion about the Medicare prescription drug plan among the different age groups. Younger boomers (51% ages 42-50) are just as likely as older boomers (52% ages 51-60) and respondents 61+ (46%) to think Medicare’s prescription drug plan will be a good thing for older Americans who have difficulty paying for their prescriptions (see Figure 2). Across all age groups less than 3 in 10 respondents think Medicare’s prescription drug plan will be bad for older Americans who have difficulty paying for their prescriptions (24% ages 42-50, 26% ages 51-60, and 28% ages 61+).

**Opinions of The Medicare Prescription Drug Plan**



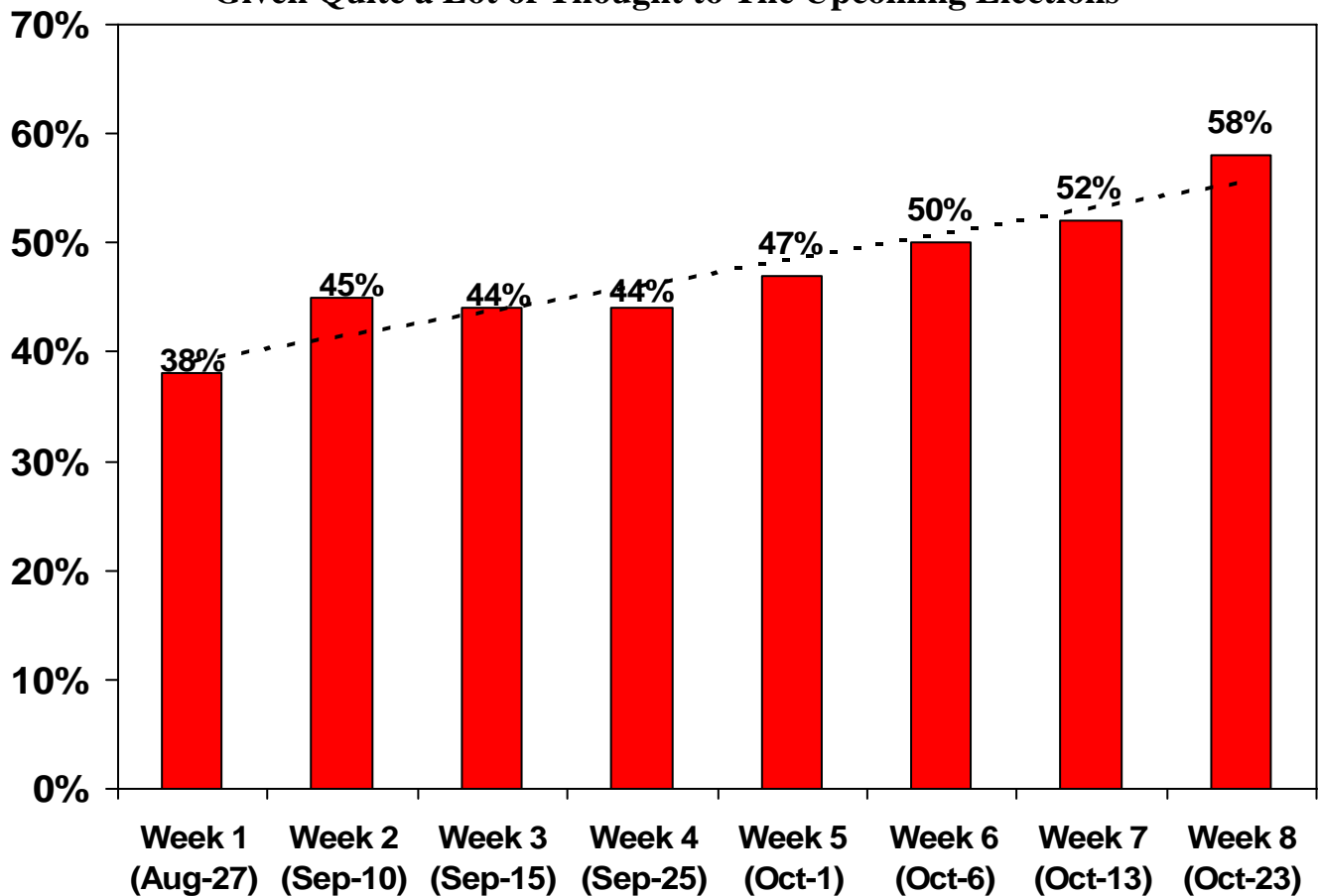
## Interest in the Mid-Term Elections

There is a considerable amount of interest in the mid-term elections. Approximately 9 in 10 respondents (88%) are interested in the upcoming elections. Nearly two-thirds are *very interested* (63%) and one-quarter are *somewhat interested* (25%). Respondents ages 51 and older are more likely to say they are *very interested* in the upcoming election than younger respondents (55% ages 42-50, 67% ages 51-60, and 64% ages 61+).

Furthermore, a greater percentage of respondents report they have given *quite a lot* of thought (58%) to these upcoming elections than those who have given *only a little* thought (27%) or no thought at all yet (13%) to the elections. In fact, over the past two months the percentage of respondents who say they have given *quite a lot* of thought to the upcoming elections has risen 20 percentage points; from 38 percent in late August to 58 percent in late October (see Figure 3). In the last four weeks of polling, the percentage of respondents who have given *quite a lot* of thought to the upcoming elections has risen 11 percentage points from 47 percent to 58 percent.

### Given Quite a Lot of Thought to The Upcoming Elections

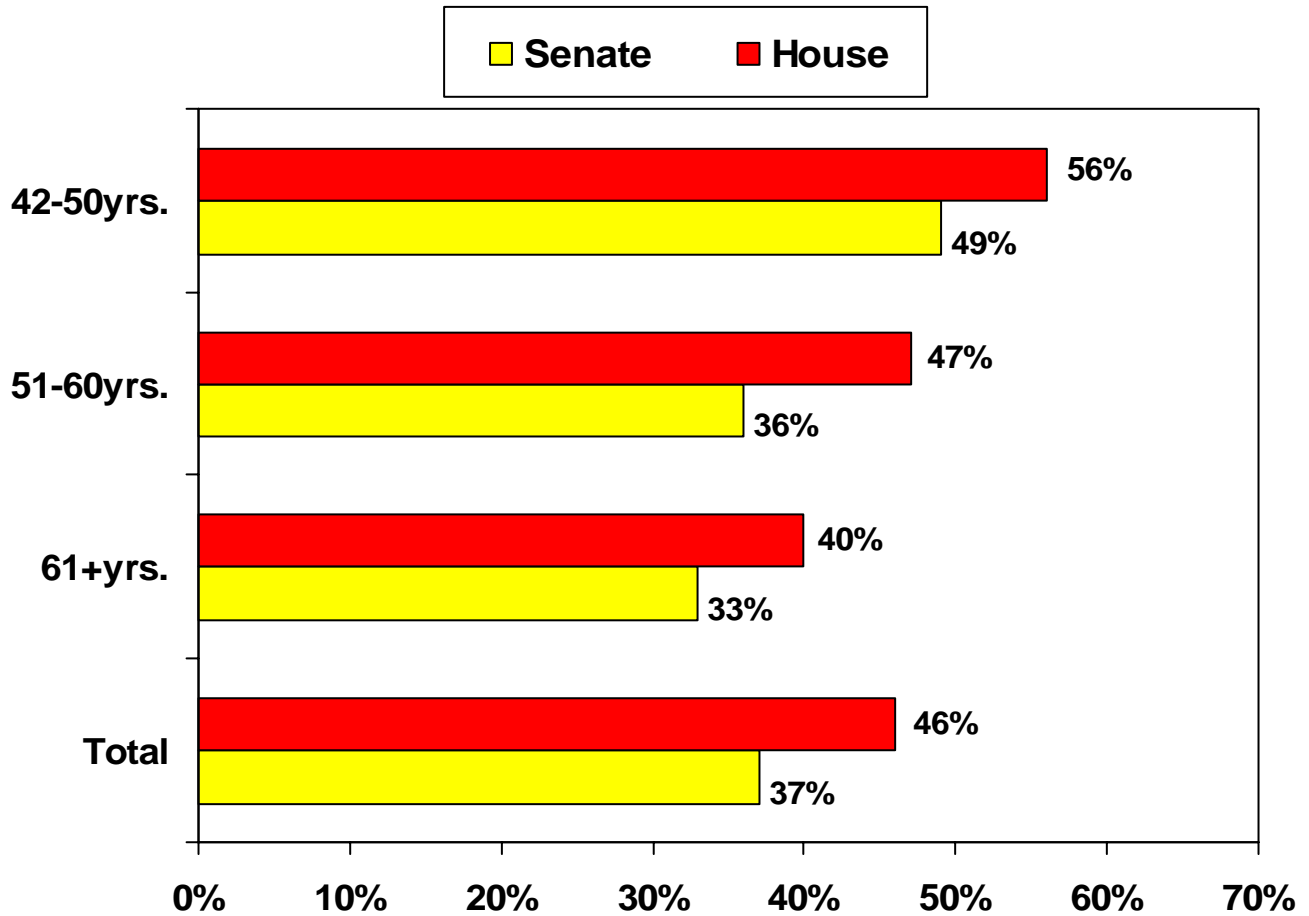




Findings suggest that a significant percentage of likely voters have made up their minds about for whom to vote. Still, slightly less than half of respondents (46%) have not yet decided for which U.S. House candidate to vote and 37 percent have not yet settled on a U.S. Senate candidate (see Figure 4).

Younger boomers are more likely than respondents 51 and older to be undecided in their voting decisions. Fifty-six percent of younger boomers, ages 42 to 50 have not yet decided for which U.S. House candidate to vote compared to 47 percent of respondents ages 51 to 60 and 40 percent of those 61+ (see Figure 4). For U.S. Senate, 49 percent of younger boomers have not yet decided for which candidate to vote compared to 36 percent of older boomers ages 51 to 60 and one-third (33%) of respondents ages 61 and older.

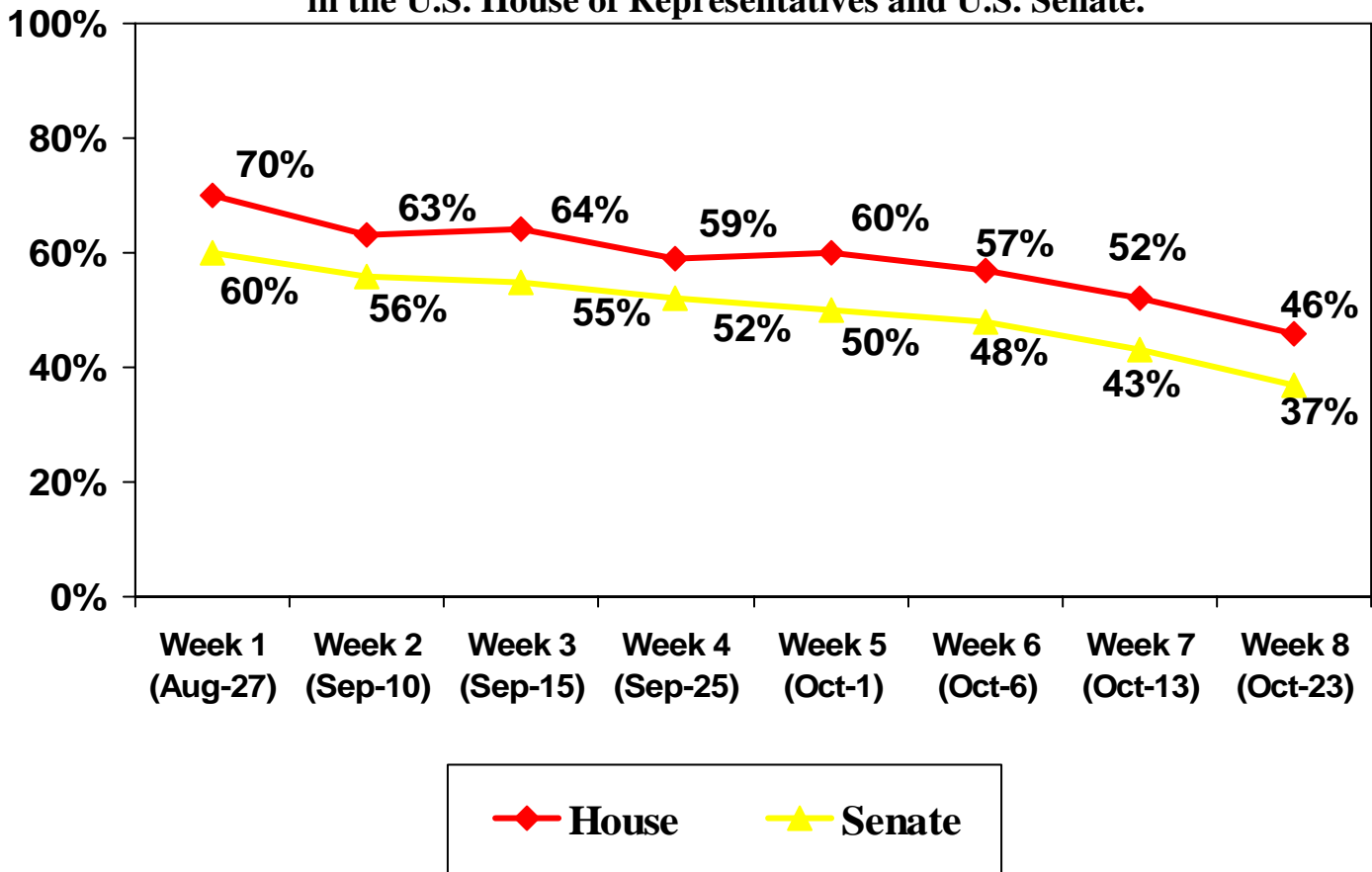

Findings suggest that over the past two months of polling there has been a decrease in the percentage of voters who have not made a decision about which candidate to vote for in the U.S. House of Representatives and in the U.S. Senate races. In late August, 70 percent of respondents had not yet decided for which U.S. House candidate to vote (see Figure 5). Currently, the percentage of respondents who have not decided for which U.S. House candidate to vote stands at 46 percent, its lowest since polling started. This is a full 24 percentage point decrease since week 1. The largest decrease in the percentage of respondents who have not made their voting decision for House candidates occurred between the first and second polling period from 70 percent in week 1 to 63 percent in week 2.

In late August 60 percent of respondents had not yet decided for which U.S. Senate candidate to vote (see Figure 5). There has been a steady decline of no more than 6 percentage points from one polling period to the next in this figure ever since. Currently, the percentage of respondents who have not decided for which U.S. Senate candidate to vote is at 37 percent, its lowest since polling started in late August. This is a full 23 percentage point decrease since week 1.

## **Candidate Attributes Considered**

While there are numerous things voters will consider before casting their vote in the mid-term elections, findings suggest that a key consideration will be whether or not voters agree with a candidate's position on major issues. When compared to other attributes such as a candidate's political party (13%), or even personal qualities of the candidate (35%), agreement on key issues (45%) is what matters most to a greater percentage of respondents. In fact, when compared to a more pertinent attribute such as a candidate's ability to help people in their own congressional district (41%), agreement with a candidate's position on major issues still came out slightly ahead (45%).

## **Conclusions**

Findings suggest that in its first year of operation there seems to be a considerable level of awareness about the new Medicare prescription drug plan. A significant percentage of boomer+ respondents report they have seen, heard, or read about the prescription drug plan. Also, a significant percentage of this boomer+ segment think the new Medicare prescription drug plan is good for people who have difficulty paying for their prescription medications.

Boomer+ voters will likely play a key role in this year's elections, and are certainly worth paying attention to. They are the most likely of any age group to be registered to vote, to always vote, to be the most interested in this year's election, and to have given quite a lot of thought to the upcoming elections for Congress.

## **Methodology**

AARP commissioned Woelfel Research, Inc., a national survey research firm, to conduct a national random digit dial (RDD) telephone survey of 1,006 people ages 42 and older. Interviews were conducted between October 20<sup>th</sup> and 23<sup>rd</sup>, 2006. This survey has a sampling error of plus or minus 3 percentage points. This means that in 95 out of 100 samples of this size, the results obtained in the sample would fall in a range of 3 percentage points of what would have been obtained if every person in the continental United States ages 42 and older had been surveyed.

For presentation purposes, percentage points have been rounded off to the nearest whole number. As a result, percentages in a given table column may total slightly higher or lower than 100%. For questions that permit multiple responses, columns may total to significantly more than 100%, depending on the number of different responses offered by each respondent. Similarly, when only selected responses are shown, percentages may total less than 100%.
